

## **TRANSIENT AIRCRAFT MECHANIC**

### **Vandenberg AFB, California**

**OCCUPATIONAL SUMMARY:** Under the direction of the Operations Manager and the TA/AGE Lead, the TA Mechanic will have an experience level consistent with the description in AFI 36-2101 of the Strategic Aircraft Maintenance Technician career field, Air Force Specialty Code (AFSC) 2A571 at the 5-level. The TA Mechanic will ensure daily duties are carried out in support of transient aircraft which include the following duties.

#### **RESPONSIBILITY AND CONTROLS FOR TA – TRANSIENT ALERT:**

- A. Provide aircraft arrival/departure services for aircraft arriving and departing Vandenberg AFB.
- B. Consults Technical Orders, manufacturers' manuals, work cards and maintenance manuals for specifications on aircraft processing, handling, and inspection.
- C. Coordinate with Base Operations Dispatch section for special needs and/or ground equipment requirements.
- D. Coordinates with aircraft crew for aircraft inspections as required.
- E. Preposition required support equipment such as fire extinguishers, ladders, chocks, and ground wires as required.
- F. Assists with aircraft fueling operations.
- G. Perform Foreign Object Damage (FOD) inspections of airfield and taxi ways as required.
- H. Must be able to obtain and maintain the required security clearance.
- I. Must maintain the required Airfield Driving certification and any other required license as required.

#### **MINIMUM DUTIES, SKILLS AND KNOWLEDGE:**

- A. Requires rounded training and experience usually acquired through a formal apprenticeship or equivalent military training and job related experience.
- B. Must be experienced in working with Military Aircraft Technical Orders or Commercial aircraft O&M manuals.
- C. Possession of commercial equivalent Airframe and Power plant (A&P) mechanic certification.

#### **MINIMUM REQUIREMENTS:**

**TA Aircraft Servicer:** Five (5) years' experience in aircraft handling and processing. Military training at the 5-level with five (5) years jet aircraft experience or an FAA Airframe and Power plant (A&P) license with 5 years jet aircraft experience is required.

## **CRYOGENICS SYSTEM OPERATOR (On-Call)**
